# A. Current Synopsis:

- The CDC is now recommending that all events that consist of 50 people or more throughout the US be canceled or postponed for the next eight (8) weeks. This includes conferences, festivals, parades, concerts, sporting events, weddings, and other types of assemblies.
- Bergen County will be the first County to implement "mass testing" given the spread in their County. Details will be announced shortly by County Executive Tedesco.
- NJ Hospital Association is considering walk-in clinics for "worried well" and asymptomatic persons. Home specimen collection also being researched and we anticipate more corporate labs coming on line to process the specimens more rapidly.
- The Attorney General's Office and NJDOH are looking into the request regarding suspending Emergency Medical Treatment and Labor Act (EMTALA) regulations. As this is a federal mandate, suspension or relaxation of these rules would have to come from the federal government. In the absence of that suspension, NJDOH advises hospitals have implemented "quick assessment" of walk-ins to mitigate concerns caused by extended admission processes.
- All New Jersey MVCs will be closed until March 30, 2020.
- Governor Phil Murphy and New Jersey Motor Vehicle Commission Chief Administrator Sue Fulton have announced that due to the COVID-19 outbreak and to protect the public, the MVC will extend expiration dates for driver licenses, registrations, and inspection stickers. Effective immediately, the NJMVC will grant a two-month extension for:
  - o Driver licenses expiring in March, April, and May
  - o Registrations expiring in March, April, and May
  - o Inspection stickers expiring in March, April, and May
- For expiration dates falling in March, the renewal deadline is extended to May; for expiration dates falling in April, the renewal deadline is extended to June; for expiration dates falling in May, the renewal deadline is extended to July. - Presidential Declaration of Emergency has been declared nationwide warranting exemption from certain Federal Motor Carrier Safety Regulations (FMCSARs) (UNDER 49 CFR § 390.23 - Emergency Declaration #2020-002). Those Code of







Federal Regulations include Parts 390 through 399 which include safe operation of commercial vehicles, parts and accessories for safe operation, and hours of service of drivers. This declaration is effective immediately and shall remain in effect until the termination of the emergency or until 11:59 P.M. (ET) on April 12, 2020, whichever occurs sooner. - As of March 15, 2020 at 1800hrs, 625 school districts have closed, 23 are for professional development and staff training, 7 are for precautionary cleaning, 510 are concerned about potential exposure for COVID-19, 83 have confirmed exposure within the school community and 2 have student, faculty or staff with presumptive or confirmed positive cases.

#### • ESF Summaries

- o ESF#1 Transportation NJ Transit has launched a dedicated web page offering a centralized location to highlight the many initiatives the agency has undertaken to protect customers and employees against COVID-19. The web page, <a href="njtransit.com/COVID19">njtransit.com/COVID19</a>, is available on both desktop and through the mobile app. In addition to outlining the steps the agency has taken, the website also includes a Frequently Asked Questions (FAQ) section. Posters reminding customers of best-practices to prevent the spread of germs will be appearing on NJ TRANSIT vehicles throughout the system in the coming days.

- o ESF #3 Public Works & Engineering / ESF #10 Hazardous Materials NJDEP continues to monitor COVID-19 situation updates and coordinate with NJESF-3 and NJESF-10 stakeholders and partners. The Water & Wastewater, Dams, Chemical & Hazardous Materials, Petroleum, Nuclear, Radiological, Solid & Hazardous Waste sectors/facilities continue to prepare and protect their operations. Main concerns that have been mentioned are staffing and supply chain shortages that could impact their abilities to ensure continuous services, adequate personal protective equipment critical for worker protection, and permit compliance. Additional conference calls will be conducted this week.
- ESF #6 Mass Care DHS Commissioner Carole Johnson wants to ensure vulnerable populations are being taken care of during this time and that all County OEMs remind all of their local jurisdictions to continue to maintain wellness checks as needed.
- ESF #7 Resource Support the probability of CERT activations remains high. Potential activations include but are not limited to staffing local OEMs (fielding 211 calls) and additional responsibilities to include food deliveries for those who are homebound. All county CERT groups have been notified through the county contacts and have advised them to begin making the appropriate preparations.
- ESF #8 NJDOH Communicable Disease Service (CDS) is accepting COVID 19 calls from local health departments, health care providers, and medical







facility staff. During regular business hours, Monday through Friday from 8am-5pm, call (609) 826-5964. After hours and weekends, please call (609) 392-2020.

- The public should continue to call the 24/7 COVID-19 hotline: 1-800-222-1222 or 1-800-962-1253 if using a non-NJ cell phone. The public hotline cannot provide information about where or how to get tested, testing results, or provide personal medical advice.
- Anticipated NJ 2-1-1 live date is Wednesday, March 18, in coordination with NJ PIES hotline to significantly increase call capacity and reduce wait time.
- Created internal NJDOH workgroup to respond to the needs of vulnerable populations during the COVID-19 pandemic.
- NJDOH is stressing that individuals with NO symptoms are not recommended to be tested. Individuals with MILD symptoms should stay home if they are sick and follow the guidance of their healthcare provider.
- o ESF #12 NJBPU BPU remains in constant contact with utility sector. Some utilities have ceased entering private homes for service calls.
- ESF #13 Public Safety & Security New Jersey Department of Corrections (NJDOC) is temporarily suspending visits for the next 30 days, effective March 14, 2020 at 1700hrs, to mitigate the spread of the COVID-19 virus.
- o ESF #15 External Communications (NJOEM) is coordinating with the Governor's Office PIO and is engaged with social media.
