

- The FMCSA National Declaration of Emergency has been expanded to cover more relief efforts in response to the coronavirus (COVID-19) pandemic. Under the emergency declaration, motor carriers and drivers providing direct assistance in support of relief efforts related to the COVID-19 outbreak are not required to comply with Parts 390 through 399 of the Federal Motor Carrier Safety Regulations. The list of products and services eligible for the exemption was expanded on Wednesday, March 18.

- o ESF #3 Public Works & Engineering / ESF #10 Hazardous Materials NJDEP continues to monitor COVID-19 situation updates and coordinate with NJESF-3 and NJESF-10 stakeholders and partners. The Water & Wastewater, Dams, Chemical & Hazardous Materials, Petroleum, Nuclear, Radiological, Solid & Hazardous Waste sectors/facilities continue to protect their operations. Main concerns continue to be staffing, supply chain shortages, exemptions for essential businesses that provide services/support to ensure continuous operations, credentialing for essential personnel, adequate personal protective equipment critical for worker protection, and permit compliance. Note: State parks, forests, recreation areas, and wildlife management areas remain OPEN to the public. However, to protect public health and safety due to the spread of COVID-19, the NJDEP has closed all park facilities (restrooms, offices, nature centers, historic buildings, playgrounds), canceled all events, and canceled all camping reservations through Thursday, April 30. Entry fees normally collected by state parks will be waived. Refunds will be issued and rescheduled events at the appropriate time. For updates: https://www.nj.gov/dep/parksandforests.

- ESF #7 Resource Support –ESF 7 Volunteer manpower is available. If manpower is needed for tasks that can be done safely given the social distancing concerns, VOAD may be able to match the volunteers to assist. They are also coordinating Private Sector donations, volunteer management, and Disability Access Functional Needs outreach through the Counties. County CERT groups have been notified through the county contacts and they have been advised to begin making the appropriate preparations.
 - Resource Management Section is processing resource requests from counties – The Department of Military and Veterans Affairs is filling some DOH requests for manpower and supplies to assist with testing sites." with DMAVA is continuing to support the DOH testing Sites.
 - A few resource requests have been sent to FEMA for processing
 - The Department of Treasury is providing requestors with vendor information for them to be able to purchase supplies on their own
 - The Department of Military and Veterans Affairs is filling some DOH requests for manpower and supplies to assist with testing sites.

o ESF #8 NJDOH -

- NJ 2-1-1 is live. Residents can also text NJCOVID to 898-211 to receive text information and stay informed. To receive live text assistance, residents can text their zip code to 898-211. This will increase call capacity and reduce wait time
- March 21 through March 22 2-1-1 received 628 calls
- Text "NJCOVID" to 898211 received **71,214** enrollments to date
- NJPIES received **351** calls March 21, 2020 with a total to date **10,400**

- Other items like cleaning products, gloves, and eye protections can still be ordered from vendors.

 - All resource requests must go through County OEMs to NJOEM. Follow normal procedures for requesting resources through E Team.

 - o PPE Non-Health (Each item needs to be submitted separately)
- For Non-Health Care facility related resource requests, the requests must be broken down into separate requests. For example, masks and gloves will go on 2 separate resource requests in ETEAM.
- Please source Household Commodity resources such as bleach, toilet paper, hand sanitizer, disinfectant wipes etc. through your own channels.
- No food, water, or office supply requests.
- Please enter an actual quantity of items needed (not cases, boxes, etc.)
- NJDOH is providing health care facilities PPE from Health & Human Services Strategic National Stockpile.

I. Weather

Weather Forecast (NWS):

Monmouth County Mobile Test Site (PNC Arts Center, Holmdel):

Tonight - A chance of rain and snow, mainly after 0400 hours. Mostly cloudy, with a low around 36. East wind 10 to 15 mph. Chance of precipitation is 30%. Little or no snow accumulation expected.

Monday - Rain. High near 45. Breezy, with an east wind 15 to 20 mph. Chance of precipitation is 100%. New precipitation amounts between a half and three quarters of an inch possible.

Monday Night - Rain, mainly before midnight. Low around 38. Northeast wind around 15 mph becoming north after midnight. Chance of precipitation is 90%. New precipitation amounts between a half and three quarters of an inch possible.

Tuesday - Partly sunny, with a high near 53. Northwest wind 5 to 10 mph becoming northeast in the afternoon.

Bergen Mobile Test Site (Bergen Community College, Paramus):

Tonight - A 30 percent chance of snow after 0500 hours. Increasing clouds, with a low around 33. Southeast wind around 7 mph.

Monday - A chance of snow before 1100 hours, then rain and snow likely between 1100 hours and 1200 hours (noon), then rain after noon. High near 42. East wind 9 to 11 mph. Chance of precipitation is 90%. New snow accumulation of less than a half inch possible.

Monday Night - Rain, mainly before midnight. Low around 38. East wind 7 to 10 mph becoming north after midnight. Chance of precipitation is 80%. New precipitation amounts between a half and three quarters of an inch possible.







Tuesday - Mostly sunny, with a high near 59. North wind 5 to 7 mph.

J. Other sources of information

- President Trump declared a nationwide emergency pursuant to Sec. 501 (b) of the Robert T. Stafford Disaster Relief and Emergency Assistance Act (the "Stafford Act). This increases federal support to the Department of Health and Human Services (HHS) as the lead federal agency for the COVID-19 response.
