

C. Field Medical Stations

• Secaucus Field Medical Station (FMS) is currently staffed by Nine (9) NJ-AHIMT, Four (4) NJ National Guard, Two (2) NJSP personnel, as well as Expo Staff and contractors. Build out is complete and the FMS should go operational as early as Monday April 6, 2020.

D. Regional Mobile Morgue Sites

- Currently, the Office of the Chief State Medical Examiner Office is coordinating with multiple partners including NJOEM, NJ DOH, FEMA and others to support a strategy to address the surge in bodies resulting from the COVID-19 pandemic.
- Mobile Refrigerator Trailers are on order (unknown delivery date)
 - o 20 trailers ordered
 - o 1,600 total capacity
- (3) Mortuary Sites:
 - o North University Hospital, Newark
 - o Central Middlesex County Fire Academy, Sayreville
 - o South TBD
- Body bags for these sites will be procured through normal channels of procurement. That may be through the county medical examiner's office or the hospitals

E. Community Based Test Sites

- Starting Sunday, March 29th, an alternate schedule will be implemented in anticipation of a maximum capacity of 500 specimen collections per day. This alternating schedule will be as follows:
 - o Bergen Site Operating: Sunday 4/5, Tuesday 4/7, Thursday 4/2 & Friday 4/9
 - o Monmouth Site Operating: Monday 4/6, Wednesday 4/8 & Saturday 4/4
- Commencing next Saturday April 4th, and all Saturdays moving forward, the Monmouth site will be dedicated to collecting samples from only symptomatic health care workers and symptomatic first responders. Until further notice this will be the alternating weekly schedule.
- Bergen County Mobile Testing Site is closed today.
- Monmouth County Mobile Testing Site opened today at 0800hrs to symptomatic health care workers and first responders.

- Newark Airport anticipated 7 targeted flights and a total of 203 passengers for screening on April 4.
- FMCSA has issued a three-month waiver in response to the COVID-19 Emergency for States and Commercial Learners Permit (CLP) holders operating commercial motor vehicles. The waiver allows a commercial learner permit driver to operate a commercial motor vehicle alone without having a commercial driver license (CDL) holder in the front seat with the learner permit holder. The benefit of this waiver will allow CLP drivers to continue their training, due to the closures of state departments of motor vehicle facilities.

- The FMCSA has extended specific waivers for expired Commercial Driver's License (CDL), Commercial Learners Permit (CLP), Non-Commercial Driver's License (Non-CDL), and Driver Medical Examiner Certifications until June 30, 2020.
- There are prerequisites to meet the waivers which are very specific for each license and medical card listed above. The details are listed in link attached below. The documents listed are the waivers and proper enforcement or more specifically the no enforcement to be taken on expired CDL's, CLP's and Non-CDL's and lists the waivers for expired medical cards, skills tests, and also lists, towards the end of the document, what does not apply to.

- ESF #3 Public Works & Engineering / ESF #10 Hazardous Materials NJDEP continues to monitor COVID-19 situation updates and coordinate with NJESF-3 and NJESF-10 stakeholders and partners.
 - NJDEP continues to monitor COVID-19 situation updates and coordinate with NJESF-3 and NJESF-10 stakeholders and partners. The Water & Wastewater, Dams, Chemical & Hazardous Materials, Petroleum, Nuclear, Radiological, Solid & Hazardous Waste sectors/facilities continue to protect their operations.







- Note: State parks, forests, recreation areas, and wildlife management areas remain OPEN to the public for passive recreation with social distancing. However, to protect public health and safety due to the spread of COVID-19, the NJDEP has closed all park facilities (restrooms, offices, nature centers, historic buildings, playgrounds, shooting/target ranges, golf courses), canceled all events and camping reservations through Thursday, April 30. - ESF #6 Mass Care DHS Commissioner Carole Johnson outlined steps the Department has taken to assist and to protect residents. Information at the following link; https://www.state.nj.us/humanservices/news/press/2020/approved/20200318b.ht
 - Working with NJOEM Resource Unit on distribution of PPE throughout the State.
 - NJDHS will serve as part of NJOEMs Non-Congregate Sheltering Task Force along with representatives from FEMA, NJDOH, and NJDCF in order to craft an approval letter to FEMA Region 2 and ensure all noncongregate sheltering missions are conducted in accordance with FEMA guidelines for non-congregate sheltering and Category B Emergency Protective Measures under Public Assistance. Letter reviewed and input provided.
 - Exploring additional facilities for future quarantine operations of Developmental Centers/ Group Home clients, if needed. Operations here will also depend on policy and contractual issues agreed upon at a higher level and in accordance with the Non-Congregate sheltering task force guidelines
 - Ensuring vulnerable populations are taken care of during this event. Coordinating with our County OEMs and other partners to identify impacted vulnerable populations and define an approach to conducting wellness checks on them, utilizing Register Ready and other sources of data. NJDHS Divisions are working closely with our Providers and those engaged with the vulnerable populations in order to get a sense of the numbers that will need continued services or wellness checks. Participated in County AFN and NJ GAINED (Groups for Access and Integration Needs in Emergencies and Disasters) conference calls to address concerns and issues. Trying to connect with additional volunteer organizations to support grocery deliveries for seniors
 - Supporting feeding operations at Bergen County College with Bergen County OEM providing the food but Red Cross ERV and staff distributing. Salvation Army supporting Ocean County Mass testing site with feeding operations until Friday at which time Ocean County OEM will provide feeding support.







- ESF6 team coordinating volunteer support for the Community Foodbank of NJ for an operation today to make 5000 food boxes. Team Rubicon and Civil Air Patrol will support in coordination with the Community Foodbank of NJ leadership.
- ESF #7 Resource Support ESF 7 Volunteer manpower is available. If manpower is needed for tasks that can be done safely given the social distancing concerns, VOAD may be able to match the volunteers to assist.
 - NJVOAD has updated http://helpnjnow.org website to accept direct cash donations for NJ Pandemic Relief Fund and other NJ organizations addressing our needs.
 - Build out of bulk purchasing, warehouse and distribution management
 - The Department of Treasury is providing requestors with vendor information for them to be able to purchase supplies on their own.
 - Continuing private sector outreach, continuing to work on volunteer management procedures, and assigning E-Team requests for PPE under NJOEM in ESF 7.
- ESF #8 NJDOH NJ 2-1-1 is live. Residents can also text NJCOVID to 898-211 to receive text information and stay informed. To receive live text assistance, residents can text their zip code to 898-211. This will increase call capacity and reduce wait time.
 - April 2 through April 3, 2-1-1 received **688** calls. Since March 18, a total of **11,510** calls have been received.
 - Text "NJCOVID" to 898211 received **114,762** enrollments to date
 - NJPIES received 457 calls April 2, 2020 with a total to date 17,227
 - Communicable Disease Service (CDS) is accepting COVID-19 calls from local health departments, health care providers, and medical facility staff. During regular business hours, Monday through Friday from 8am-5pm, call (609) 826-5964. After hours and weekends, please call (609) 392-2020.

K. Resource Management

- Resource Management Section is processing resource requests from counties –
 The Department of Military and Veterans Affairs is filling some DOH requests for
 manpower and supplies to assist with testing sites.
- Sixteen (16) Resource Request Forms have been sent to FEMA for processing.
- Build out of bulk purchasing as well as warehouse and distribution management.
- No resource requests for medicine are to be accepted or entered into ETEAM.
- When an agency is submitting a resource request via ETEAM, please ensure that the requesting agency is listing their organization in the "Requesting Organization" field (i.e. XXXXX County, New Jersey Department of XXXXXXX, etc.). For all County OEM Agencies, please add a summary note in the "Summary of Actions Taken" whether the County Agency can or cannot fill the request and why it cannot be filled (i.e. All vendors have been contacted, vendors cannot meet the request and that you have advised the requester they should continue to reach out to their vendors).
- Additionally, please include the timeline of "When Needed" and "Quantity of Unit of Measure" filled in (i.e. 1,000 nitrile gloves or 250 N95 masks, etc.).
- All State bid vendors are out of stock or back-ordered on all masks and hand sanitizer.
- Other items like cleaning products, gloves, and eye protections can still be ordered from vendors.
- For specific procurement guidance from Treasury, refer to memo sent from the NJEOC on March 15th at 1557hrs.
 - o All resource requests must go through County OEMs to NJOEM. Follow normal procedures for requesting resources through E Team.







- o For PPE Requests, please enter the following in the Block "Tracking Number State"
 - PPE Health (Health can submit in bulk)
 - PPE Non-Health (Each item needs to be submitted separately)
- For Non-Health Care facility related resource requests, the requests must be broken down into separate requests. For example, masks and gloves will go on 2 separate resource requests in ETEAM.
- Please source Household Commodity resources such as bleach, toilet paper, hand sanitizer, disinfectant wipes etc. through your own channels.
- No food, water, or office supply requests.
- Please enter an actual quantity of items needed (not cases, boxes, etc.)
- NJDOH is providing health care facilities PPE from Health & Human Services Strategic National Stockpile
