HARPSTER, RESPONDED TO PRINCETON DETOX FOR A REPORT OF A HIGHLY INTOXICATED MALE.</p> <p>UPON MY ARRIVAL, I OBSERVED EMPLOYEES IN THE WINDOW. THEY POINTED TOWARDS THE FRONT LOBBY. WHEN I APPROACHED THE DOOR FOR THE LOBBY, I HEARD LOUD SCREAMING THAT SOUNDED LIKE A MALE'S VOICE. AS I WAS REACHING TO OPEN THE DOOR, LONDON MCDONALD, CAME BARGING THROUGH THE DOOR.</p> <p>I THEN TOOK A STEP BACK AND OBSERVED L. MCDONALD PROFUSELY SWEATING, WITH NO SHIRT ON. HE HAD DROOL COMING FROM HIS MOUTH AND HIS SPEECH WAS SLURRED AND BOISTEROUS. I ATTEMPTED TO DE-ESCALATE L. MCDONALD BY VERBALLY TALKING TO HIM. I ATTEMPTED TO MAINTAIN A SAFE DISTANCE, HOWEVER HE CONTINUED TO TRY TO CLOSE THE GAP BETWEEN US.</p> <p>WHILE SPEAKING WITH L. MCDONALD HE BECAME INCREASINGLY VERBALLY AGGRESSIVE. HE THEN JUST BEGAN TO STARE BLANKLY AT ME. I OBSERVED HIS HANDS DOWN BY HIS WAIST LINE AND I FURTHER OBSERVED HIM CLENCHING HIS FISTS.</p> <p>PFC. GAGAN CHOPRA THEN BEGAN CONVERSING WITH L. MCDONALD AND L. MCDONALD STATED THAT HE WAS LEAVING. AT THAT POINT, PFC. CHOPRA STARTED GUIDING HIM TOWARDS THE AMBULANCE. (SEE PFC. CHOPRA'S REPORT FOR FURTHER).</p> <p>AS L. MCDONALD WAS WALKING UP THE STAIRS VOLUNTARILY INTO THE AMBULANCE, HE JUMPED TO THE FLOOR AND BEGAN SCREAMING. HE STATED THAT HE WAS GOING TO "SUE US" BECAUSE WE THREW HIM TO THE GROUND. HOWEVER, BOTH PFC. CHOPRA AND I WERE BOTH STANDING ON THE BLACKTOP STILL AND DID NOT ENTER THE AMBULANCE.</p> <p>L. MCDONALD'S DEMEANOR BEGAN TO CHANGE AS WELL. HE THEN BEGAN CRYING ON THE GROUND AS WE WERE ATTEMPTING TO SIT HIM UPRIGHT. AS I WAS ATTEMPTING TO GET HIM TO SIT UPRIGHT, I PUT OUT MY RIGHT ARM TO ASSIST HIM IN STANDING UP. HE PURPOSELY BEGAN TO TRY TO PULL ME TO THE GROUND. HE THEN BECAME MORE AGGRESSIVE TOWARDS OFFICERS AND THE EMT'S ON SCENE. DUE TO HIS AGGRESSIVENESS, HE WAS PLACED INTO PROTECTIVE CUSTODY.</p> <p>I THEN GRABBED HIS LEFT ARM AND PULLED HIM UP INTO A KNEELING POSITION. I UTILIZED AN ARM BAR ON HIS LEFT ARM AND PLACED A HANDCUFF ON HIS WRIST. PFC. CHOPRA HAD A HANDCUFF ON HIS RIGHT WRIST AT THAT TIME AND WE LINKED THEM TOGETHER DUE TO HIS LARGE SIZE.</p> <p>WE THEN ATTEMPTED TO SIT HIM UP, HOWEVER HE RESISTED SITTING UP. HE THEN BEGAN WEEPING. WE EVENTUALLY WERE ABLE TO SIT HIM UP AND PLACED HIM ONTO A CHAIR. WHILE SITTING HE CONTINUED TO BE VERBALLY AGGRESSIVE TOWARDS POLICE AND EMT'S.</p> <p>L. MCDONALD WAS THEN PLACED ONTO THE STRETCHER AND HAD TO BE SECURED TO KEEP HIM FROM KICKING AT THE EMT'S....</p>
